St. Josephs Inpatient and Outpatient Rehab:

OUTPATIENT: St. Joseph's serves residents of Franklin and Essex Counties at six outpatient services clinics. These clinics are currently located in Malone, Tupper Lake, Saranac Lake, Lake Placid (Mountain Lakes Academy), Elizabethtown, Keeseville and Ticonderoga: Offering intensive case management, assessment, individual and group counseling addressing Early Recovery Skills, Recovery Issues, Relapse Prevention, Continuing Care and Co-Dependency. We also offer assessment, and individual and group counseling for Vocational Rehabilitation Services. Referrals for services based on clients' needs to Medical Services, Mental Health/Psychiatric Services, Career/Employment/Educational, Financial Counseling, Legal Services, and Self Help & Recovery Groups are also available through the clinics. In addition to the services offered at the Outpatient Clinics, we provide assessment, individual and group counseling addressing Early Recovery Skills, Recovery Issues, Relapse Prevention, Continuing Care and Co-Dependency, and after-care planning at the Franklin and Essex County

Admissions/Referrals

Our admissions process is completely confidential and is dedicated to assisting those experiencing difficulties with alcohol and other substances. Prospective clients may call us on their own, or be referred by family, physicians, employers, health care agencies, school personnel, legal professionals, insurance companies and or private practitioners. Treatment is covered by most third-party payers, health plans and Medicaid. However, in the event that a health care plan does not cover this level of care, a self-pay arrangement can be discussed and implemented based upon need. (518) 643-0148 Champlain Valley Family Center's Recovery Campus has stabilization and rehabilitation services that are provided in a residential setting in Schuyler Falls, NY. This is an Office of Alcohol and Substance Abuse Services (OASAS) certified program. The facility is 18 beds serving men and women, age 18 and older, who have an identified substance use disorder and are in need of a more intensive level of care. It is a 24 hour a day, 7 day a week program with full time medical and clinical staff supervision. The program will provide:

- Medical Stabilization and Withdrawal Management
- Medication Assisted Treatment
- Individual and Group Counseling
- Educational Lectures
- Recreational Activities
- Life Skills
- Leisure Skill Activities
- Yoga, Mindfulness, and Stress Management
- Family Therapeutic Sessions
- Vocational and Educational Counseling
- Psychiatric Evaluation and Medication Management
- Comprehensive Discharge Planning

These individuals can be referred from outpatient treatment programs, hospitals, legal entities, family members, themselves, or other community agencies.
